By signing this agreement, I agree that:

- I will pay the agreed amount to Little Monkeys Playcentre and Cafe via a weekly direct debit (EziDebit), amounts as per the EziDebit Agreement Form signed.
- If my child moves up an age bracket, and the membership for that age is a higher price, the customer agrees to sign a new EziDebit form at the new rate. Failure to do so within 2 weeks of the child's birthday may result in their membership being cancelled.
- Should there be any declined transactions, it is my responsibility to contact Little Monkeys to arrange payment, or my membership will be cancelled. I understand that EziDebit may charge me a dishonour fee.
- I will keep my payments one week in advance at all times.

- I will give a minimum of one weeks **written** notice (we prefer email) to cancel my direct debit and Little Monkey's membership.
- If my membership payments are not paid up to date, my child will not be able to play, unless I pay the standard play fees to Little Monkeys or fix up the outstanding direct debit amount.
- I will notify Little Monkeys of any change in bank accounts, and it is my responsibility to notify Little Monkeys when my credit card expires, what my new details are.
- I am responsible for any fees incurred by my bank in relation to any overdrawn accounts that may occur as a result of Little Monkeys direct debiting my account, as per our written agreement.
- I agree to photographs of my child/children and myself being used in Marketing materials including online.
- Memberships may be placed on hold for 2 weeks at a time only due to medical, holiday or financial hardship, and only where a written request is sent via email and confirmed by our Manager. Holds can only be a maximum of a total of 4 weeks per year.
- Little Monkeys reserve the right to stop offering this membership structure at any time, and can do so to the customer with 1 weeks notice in writing (and via email).
- Little Monkeys reserve the right to refuse membership to anyone for any reason at its sole discretion or cancel membership to anyone with 1 weeks notice, or less should the Manager feel it is necessary.
- The fees are per child and may come out of your account as one debit per child per week.
- In consideration of allowing entry to Little Monkeys Playcentre and Cafe, I the undersigned Supervising Adult (or guardian, parent or carer) agree to release, indemnify, and hold harmless Little Monkeys Playcentre and Cafe, it's owners and it's officers, agents and employees from any cause of action, claims or demands of any nature whatsoever, including but not limited to a claim of negligence, that I or the children listed above may have now or in the future on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to entry to and/or use of the facilities of Little Monkeys, to myself or the children in my care. I understand this is a legally binding document and I certify that I am signing it after having read and understood it.
